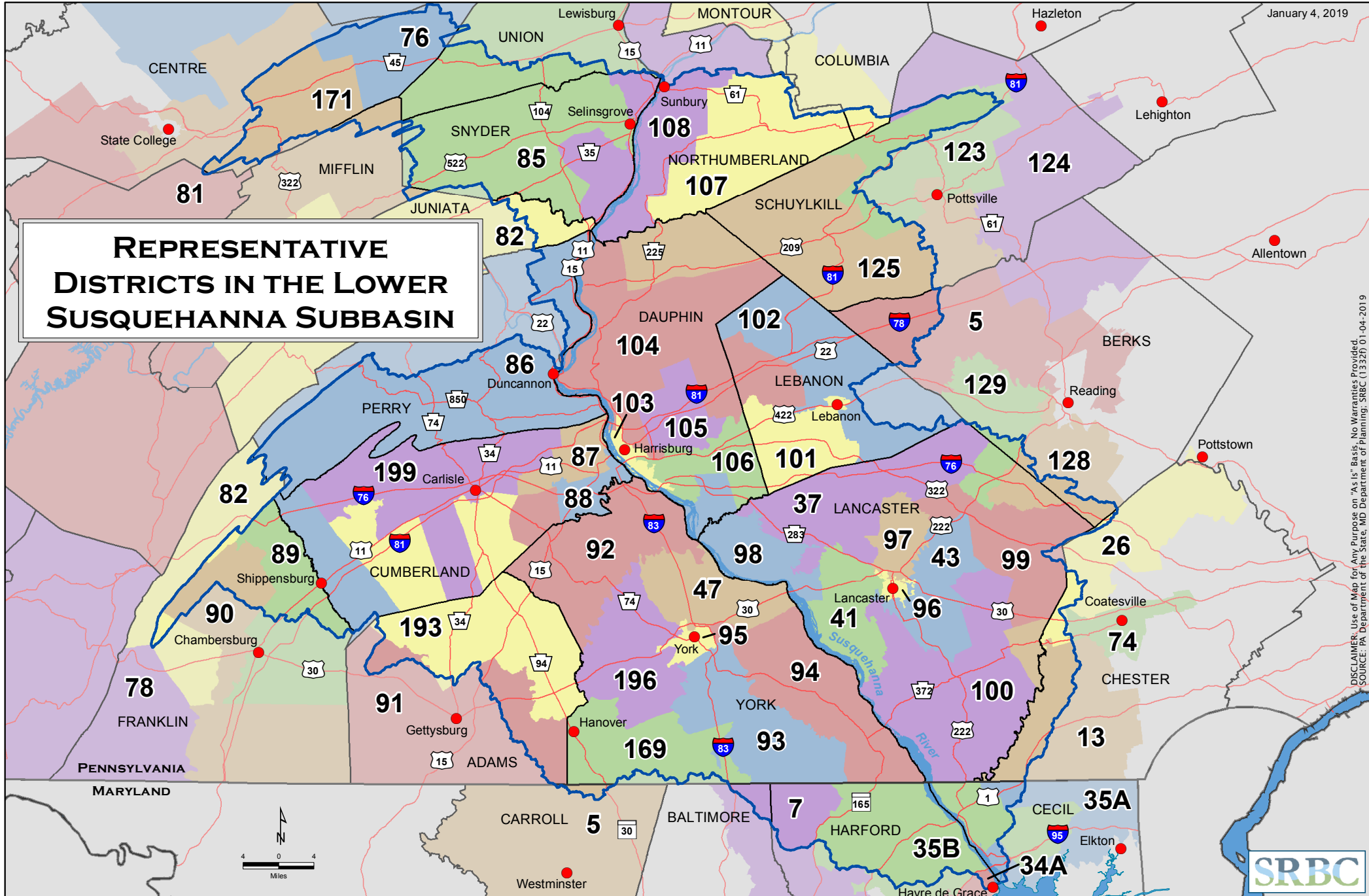


REPRESENTATIVE DISTRICTS IN THE LOWER SUSQUEHANNA SUBBASIN
