The appropriate fee, as specified in the current Commission's Regulatory Program Fee Schedule in effect at the time of submission of this form, will be determined during review. Notification of the appropriate fee will be provided to the project sponsor. The request for transfer or reissuance will not be finalized until the appropriate fee has been paid.

Upon reissuance or transfer of the approval, if not already subject to the Annual Compliance and Monitoring fee (ACMF), the facility will be subject to the ACMF. An invoice will be issued and payment for the fee will be due within thirty (30) days of invoice date.

Please note that the new project sponsor must operate the project subject to the same terms and conditions of the existing approval. If the new project sponsor seeks to modify any terms and conditions of the existing approval, a separate application to the Commission for modification must be submitted and Commission approval obtained prior to making changes.

I, the undersigned, hereby certify that I am a legal representative of the project sponsor submitting this request and that I have the authority to do so.

I understand that failure to comply with the terms and conditions of the approval(s), and all applicable requirements of § 806.6, including all submissions required thereunder, may subject the project sponsor to enforcement action in accordance with Part 808 of Commission regulations.
