## TOWN OF CHENANGO 12A WELL PROJECT FACILITY DESCRIPTION (NYSDDOH PWS ID#NY0301653) May 18, 2017

The Town of Chenango owns and operates the existing 12A Well at 70 Chenango Bridge Road (NYS Route 12A) in the Town of Chenango, Broome County, New York. The well and pumphouse are within easements on the referenced property and are adjacent to Thomas Creek and the Chenango River. The following is facility information required for the well:

- a. Site/Facility Name: 12A Well
- b. Current Owner:Town of ChenangoLong Term Owner:Town of Chenango

Current Operator:Town of ChenangoLong Term Operator:Town of Chenango

- c. Type of Facility: Municipal Water Supply
- d. List of existing Water Sources: The 12A Well and Cherry Lane Well are both groundwater withdrawal wells connected directly to this municipal water system. 12A is the primary water supply while Cherry Lane remains in an 'off' state. The system is interconnected with the Northgate Well mainline, however the interconnection is 'closed' with a valve and is not opened except for emergency.
- e. Description of existing/planned water use at the facility: Current water usage averages 0.372MGD, however historically the system maximum 30-day daily average has been between 0.500 and 0.600 MGD several times within the last decade. Planned water use is expected to not exceed 0.600 MGD.
- f. Available/Planned water storage capacity: Two above ground water storage tanks provide for 0.72 million gallons of storage capacity (Hospital Hill Tank = 500,000 gallons; Poplar Hill Tank = 219,900 gallons). No changes are project.
- g. Location of return flow outfall:Not applicable.
