- a. Bulk water hauling facility that will include a loadout building that will require maintenance of an access road for tanker trucks.

D. Purpose of the withdrawal

- a. Bulk water hauling pursuant to 25 Pa. Code Chapter 109.

E. Description of Site activities

- a. Site activities will consist of tanker trucks entering the Site, filling trucks from a loadout building, and leaving Site. The Site will be maintained in a mostly undeveloped state.

F. The requested quantity of water to be withdrawn

- a. 324.5 gpm (0.467 mgd)

G. Provide the date operations began at the Site or are anticipated to begin

- a. Operations will commence following approval from all regulatory agencies (i.e. SRBC, PADEP, Township Boards, etc.). The current anticipated start date is January 1, 2019.

The Deep Woods Lake, LLC Site, located in Butler, Dennison, and Foster Townships, Luzerne County, Pennsylvania, was previously approved by Susquehanna River Basin Commission (SRBC) on December 14, 2000 (Docket No. 20001201) to withdraw 0.360 million gallons per day (mgd) and 0.108 mgd (0.468 mgd total) from wells SW-5 and SW-4, respectively. Additionally, Pennsylvania Department of Environmental Protection (PADEP) issued a draft PWS permit for the operation of wells SW-5 and SW-4 at 250 gallons per minute (gpm) (0.360 mgd) and 75 gpm (0.108 mgd), respectively, for a cumulative withdrawal rate of 325 gpm (0.468 mgd). However, since no action was taken to connect Site wells to the adjacent Beech Mountain Lakes (Beech Mountain) residential system by Beech Mountain under Public Water Supply (PWS) Permit No. 2400114, the previously-approved SRBC docket has since expired. All Site wells remain unconnected from any water supply system. The proposed bulk water withdrawal rate from SW-5 is 324.5 gpm (0.467 mgd). Deep Woods proposes to maintain the majority of the Site in an undeveloped state.

Deep Woods Lake, LLC anticipates owning and operating this source for bulk water hauling pursuant to 25 Pa. Code Chapter 109. Revenue from the operations will be utilized to maintain the Site, which encompasses the majority of the watershed, in a primarily undeveloped state.
