## **Existing Facility Information**

This project is an existing water withdrawal located in Fell Township, Lackawanna County, PA. The waterway for the existing water withdrawal is the Lackawanna River (HQ-CWF-MF). The staging area is on the property of the Lackawanna County Railroad Authority and leased by Linde Corporation (Linde). The withdrawal site is on the property of Carbondale Industrial Development Authority and leased by Linde. The Lackawanna River is designated as a HQ-CWF-MF under PA Code 25 Chapter 93. The existing withdrawal includes a custom buried intake, withdrawal pump, flowmeter, and staging area. The existing staging area includes 4 existing frac tanks with manifolds, allowing 4 trucks to fill at one time.

A surface water withdrawal of up to 905,000 gallons per day with a maximum instantaneous withdrawal rate of up to 700 gallons per minute from the Lackawanna River (HQ-CWF-MF) is approved under Docket No. 20150307.

No modifications are proposed at this time. The purpose of this application is a renewal of the surface water withdrawal docket.
