## SECTION 2.1 PROJECT FACILITY DESCRIPTION

Columbia Water Company Marietta Division's (CWC-MD) alternates pumping Well 2 (Docket No. 2017-007) and Well 3 (Docket No. 2017-008) to provide the potable demand for the service area, and a portion of York County. The service area includes Marietta Borough and portions of East Donegal Township in Lancaster County, and a small area in Hellam Township, York County.

CWC-MD supplies residential, industrial, commercial, and public potable water as a public water system in portions of Marietta Borough and East Donegal Township (Lancaster County) and Hellam Township (York County). The main sources of the CWC-MD water system are Well 2 and Well 3. A water pipe from the Lancaster side supplies the customers in Hellam Township for the majority of the year, supplemented by Well 4 (also known as the Dugan Well). The Dugan Well is located in York County.

Without interrupting operations, in October 2012, the Columbia Water Company (CWC) purchased the Marietta Gravity Water Company's (MGWC's) water system. CWC itself was incorporated in 1823. The MGWC system is isolated from the CWC system except for an emergency interconnection which hydraulically can only allow water to flow from the CWC system into the MGWC system. The anticipated long-term owner and operator of the water system is Columbia Water Company, Marietta Division.

The MGWC was founded circa 1892, and was sourced by two reservoirs in Hellam Township, York County. Two pipelines (one 10-inch and one 12-inch diameter) underneath the Susquehanna River fed the water from the reservoirs to Marietta Borough and portions of East Donegal Township. Use of the reservoirs ceased in the mid-1990s due to PADEP regulations requiring filtration of surface waters. MGWC had also drilled three water supply wells in the late 1950s and early 1960s (Wells 1, -2, and -3) on the eastern shore of the Susquehanna River to supplement the reservoirs. Well 1 was abandoned when Pennsylvania State Route 441 was constructed.

In 2002, MGWC drilled emergency wells in Hellam Township due to a break in the pipelines under the Susquehanna River between the Lancaster and York County sides. The Dugan Well 4 (hereafter referred to as the Dugan Well) was drilled in 2002 to a depth of 400 feet. The Dugan Well is a low capacity well, providing emergency service to the connections in Hellam Township, York County. An Aquifer Test Plan Waiver for the Dugan Well was submitted to the SRBC in November 2016, and approved in 2018.

The main source for MGWC are the wells located in Lancaster County. Chickies Wells 2 and 3 have been in operation since the 1960s, subject to the PADEP's regulations for community water supplies. Well 1 was replaced by Well 2 in 1963Well 2 was advanced to a depth of 133 feet with 119 feet of total casing. Well 3 was advanced to a total depth of 256 feet with 180 feet of total casing.

### CWC-MD is requesting no changes in the water withdrawal.

Based upon the findings of this investigation and published information, the CWC-MD wells support the following pumping rates:
