## **2.1 Project Facility Description**

Cabot Oil & Gas Corporation is a natural gas exploration company requesting renewal of the approval for a surface water withdrawal of 1.500 million gallons per day (mgd) from the Susquehanna River located in Susquehanna Depot Borough, Susquehanna County, Pennsylvania. Cabot Oil & Gas Corporation owns and operates the existing surface water withdrawal facility, which is currently approved under Docket No. 20161202 and has been in operation since 2012. The purpose of the project facility is to provide freshwater for hydrocarbon development and related incidental uses within the Susquehanna River Basin.

Water is withdrawn via an aboveground pump connected to a screened floating intake structure in the Susquehanna River. Withdrawn water is transported via waterline to four on-site 21,000-gallon storage tanks located southeast of the intake. There are four truck filling terminals at the tanks. Water is transported from the facility via trucks for consumptive use at approved natural gas well drilling pads. No changes to the project, or to the amount or rate of water withdrawal and consumptive use are proposed.
