## Project Facility Description

Eagles Mere Country Club is requesting to renew Docket No. 19970302, which authorized the withdrawal of .12 mgd at the Eagles Mere Lake, a privately owned lake located in Eagles Mere Borough, Sullivan County, PA

The 18-hole golf course at Eagles Mere Country Club (EMCC) has been operating since approximately 1911 and is a member owned club. Irrigation water for tees, greens and fairways was provided from sometime in the 1930s by the Eagles Mere Water Company, which obtains its water from the 230-acre Eagles Mere Lake. The water company disbanded. In 1997, EMCC began to pump water directly from its own well. On an as needed basis, EMCC also pumps water from Eagles Mere Lake into a one-and-a-half-acre storage pond on our property.

Ground water is pumped from the irrigation well and discharged into our storage pond and wet well adjacent to the irrigation well. Water will be pumped from the wet well into the irrigation system to water the tees, greens, and fairways. EMCC will maintain its connection to the Eagles Mere Lake to obtain water on an as-needed basis.

We are permitted to use .12 mgd and there are no proposed changes. Eagles Mere Country Club contains one 18-hole golf course.
