#### DETAILED PROJECT DESCRIPTION

Millersburg Area Authority operates a public water system serving ~4200 residents of Millersburg Borough and parts of Upper Paxton Township. Well 14 is an existing groundwater source located just South of Power Company Road, Upper Paxton Township, Dauphin County, Pennsylvania (the Site). The groundwater withdrawal application for Well 14 requests a 30-day average withdrawal rate of 0.117 mgd and a maximum instantaneous withdrawal rate of 590 gpm.

In 1993 the SRBC approved the groundwater withdrawal of up to 0.46 million gallons per day (mgd) from two groundwater wells (Well 14 and Well 15) under Docket 19930301. Since 1993, Well 15 was scarcely utilized as a source because of poor water quality, so MAA does not intend to include Well 15 in Docket 19930301 renewal.

The water from Well 14 is used to provide potable water to Millersburg Borough and parts of Upper Paxton Township. Wastewater from our service area is treated at our wastewater treatment facility, located at 10 MYO Park Road, and discharged to the Susquehanna River basin under an NPDES permit.

A Voluntary Action Plan (VAP) was developed by Susquehanna River Basin Commission (SRBC) staff to assist the Millersburg Area Authority (MAA) with the application renewal process for Wells 14 and 15. The May 5, 2020, VAP was revised after MAA provided additional data and information that was not provided or considered during the development of the initial VAP. The June 2, 2021, Revised VAP is the plan which we are basing the renewal of Well 14 upon.
