Project Facility Description

Huntsville Golf Club is requesting to renew Commission Docket No. 19920909 which authorized the consumptive use of a peak day rate of up to 0.788 million gallons per day (mgd). Water for the project is supplied from on-site storage ponds that collect surface runoff.

Huntsville Golf Club which is located in Lehman Township, Luzerne County, Pennsylvania was built in 1992. Huntsville Golf Club is an 18-hole private golf course. The golf course has 4 acres of greens, 3 acres of tees, 25 acres of fairways and 120 acres of rough. There are 3 storage ponds on the property. The Hayfield Pond (6 acres), #12 pond (2 acres) and #7 pond (1.5 acres). Transfer lines allow us to move water from the Hayfield Pond and #12 pond to the #7 pond where the water is withdrawn for consumptive use.

Water is used at the site for the purpose of irrigating the golf course. The water usage is seasonal and typically begins sometime in April and concludes by early November.

The only proposed change to the renewal is switching from 0.788 mgd peak day rate to 0.5 mgd on a 30 day average.
