2.1 Project Facility Description

Seneca Resources Company, LLC is a natural gas exploration company requesting renewal of the approval for a surface water withdrawal of 0.499 million gallons per day (mgd), when available, from the Arnot No. 5 Mine Discharge located in Bloss Township, Tioga County, Pennsylvania. Seneca Resources Company, LLC owns and operates the existing Arnot No. 5 Mine Discharge surface water withdrawal facility, which is currently approved under Docket No. 20180305. The purpose of the project facility is to provide freshwater for hydrocarbon development and related incidental uses within the Susquehanna River Basin.

The intake consists of a submersible pump suspended within the water channel located 90 feet downgradient of where the mine discharge exits the subsurface. The abandoned mine discharge is identified as DJC900 in SRBC Publication No. 230 and drains south to an unnamed tributary to Johnson Creek in Bloss Township, Tioga County, Pennsylvania. A waterline conveys water from the intake to a central water storage impoundment located 500 feet to the east. Waterlines are also capable of conveying withdrawn water to a water truck fill and load-out station adjacent to and east of the intake for approved consumptive use. No changes to the amount or rate of water withdrawal are proposed.

Seneca requests that SRBC Policy No. 2021-04 titled *Fee Incentives for Withdrawal and Consumptive Use of AMD Impacted Waters and Treated Wastewater* be considered for this project. Additional information for this request is provided in the application.
