Section 2.1 Project Facility Description

- A. Site/Facility Name: Corning Incorporated's corporate headquarters (HQ)
- B. Site Owner/Operator: Steuben County Industrial Development Agency/Corning Incorporated
- 1. **Type of Facility:** Corning Incorporated's HQ property is an approximately 20-acre parcel located on the south side of the Chemung River in the City of Corning, New York. The site includes the 487,000 square foot headquarters building, a utility building, and multi-level parking garages.
 - C. **Purpose of the Withdrawal:** Potable water is provided to the site through connections with the City of Corning, New York. However, Corning Incorporated operates four (4 production wells (HQ-5A, HQ-6A, HQ-8A and HQ-9A) for the withdrawal of groundwater for mechanical heating and cooling of the buildings. The current water demand varies seasonally and is met by the operation of one or more of the four existing Corning Incorporated production wells. Increases in the planned water withdrawal at the HQ facility is not anticipated.
 - D. **Description of Site Activities:** The site includes the corporate headquarters for Corning Incorporated and houses business and administrative operations for Corning Incorporated.
 - E. **The requested quantity of water to be withdrawn:** Corning Incorporated is renewing their existing SRBC docket (19981201) for the withdrawal of up to 1.44 MGD from Well HQ-6A.
 - F. **Date that Operations began at the facility:** The Corning Incorporated HA property was developed and began operation in 1998.
