## 2.1 Project Facility Description

Repsol Oil & Gas USA, LLC is a natural gas exploration company requesting renewal of the approval for a surface water withdrawal of up to 0.926 million gallons per day (mgd) from an unnamed tributary to North Branch Sugar Creek located in Columbia Township, Bradford County, Pennsylvania. Repsol Oil & Gas USA, LLC owns and operates the existing surface water withdrawal facility, which is currently approved under Docket No. 20180611, and which has been in operation since 2010. The purpose of the project facility is to provide freshwater for hydrocarbon development and related incidental uses within the Susquehanna River Basin.

When there is adequate flow in the unnamed tributary to North Branch Sugar Creek, water is withdrawn via a centrifugal pump connected to a submerged intake installed on the stream bed. Water is conveyed from the intake via a buried waterline to the withdrawal pump located in a pump house approximately 300 feet southeast of the intake. Withdrawn water is transported from the pump house via a buried waterline to a 5.7-million-gallon freshwater storage impoundment located approximately 130 feet north of the pump house. Water from the impoundment is primarily transported via buried waterlines to other impoundments in Repsol's water distribution and storage network and to approved natural gas well drilling pads for consumptive use. Occasional trucking of water from the impoundment is conducted as needed. No changes to the project are proposed.
