The Susquehanna Gas Field Services, LLC approved withdrawal site on the Susquehanna River (Black Walnut site) is located on the main stem of the river, approximately 35 ft outward from the water edge. The withdrawal site has been in use since 2014. The water withdrawal intake, pump/meter/controls trailer, and loading stations are located south of U.S. Route 6 and the Lehigh Valley Railroad tracks near Black Walnut River Road.

The project facility consists of the surface water intake structure; trailer-contained pumping, metering, and controls equipment; force main piping, water storage facilities (frac tanks), and a water truck loading station area located near the railroad tracks. A complete description of the site and associated pumping and metering equipment is provided in the approved Metering Plan dated April 11, 2014 (latest revision May 8, 2018).

This application is for the renewal of SRBC Docket No. 20180614, which approves a withdrawal of up to 1.650 million gallons per day (mgd) of surface water from the Susquehanna River, with a maximum instantaneous rate of withdrawal of 1,389 gallons per minute (gpm), at the Susquehanna Gas Field Services, LLC (SGFS) – Black Walnut site. The project sponsor is requesting the renewal of the approval with no planned changes in the existing site and no requested change in the presently approved withdrawal rate or quantity.

The water from this site is used for Bulk Supply for Hydrocarbon Development, Hydrostatic Testing, Dust Suppression, Quarrying Operations, and Related Incidental Uses.
