## 2.1 – Project Facility Description

Eagles Ridge Golf Course, owned by Coal Mountain Development & Recreation, LLC is requesting to renew Commission Docket (Pending): SRBC 2022-098, which authorizes the withdrawal of .099 million gallons per day (mgd) from a storage pond in the headwaters of an Unnamed Tributary to Watts Creek and the peak withdrawal rate not to exceed 600 gallons per minute (gpm). This surface water withdrawal facility is located in Ferguson Township, Clearfield County, Pennsylvania on property owned by Coal Mountain Development & Recreation, LLC. NO changes to past authorized uses are requested at this time.

The proposed water withdrawal will be from an approximately 1-acre pond located on the facility property and used specifically for the irrigation of its greens, tees, fairways and some rough as needed at no more than the above stated rates.

Eagles Ridge Golf Course is an 18-hole golf course located at 122 WM Cemetery Road in Curwensville, PA. Site activities are specific to all those related to general golf course practices.
