Spring Creek Golf Course is a nine-hole public golf course that has been in operation since the 1930's. The golf course sits on 30-acres along U.S. Route 422 east of Hershey, Pennsylvania, in Dauphin County. Previously Spring Creek Golf Course was operated by the Hershey Entertainment & Resorts Company and as of August 1st, 2021, operations were transferred to the Milton Hershey School. The course, greens, tees, and fairways are irrigated from a pumping station on Spring Creek.

The irrigation system was updated in 2006 and features a computer-controlled operation of the distribution system. Additionally, the system was expanded to allow irrigation of the fairways. The pumping station is located on the south side of Chocolate Avenue approximately 3000-ft upstream of the Hershey Country Club pumping station. At this time, no changes are proposed to the facility or operations.

The Spring Creek Golf Course is applying for a Consumptive Use Permit Renewal. This is appropriate because the course has been consumptively using water from Spring Creek as its own entity since the initial application in 2008. The previous usage requested was 81,000-gpd, which is based on conservative usage calculations by Science Applications International Corporation, in which the irrigation system is shown to be used at the required schedule to maintain the greens, tees, and fairways during a worst-case dry season. Usage reports from quarters 1-3 in 2022 show a maximum consumptive use of 47,515-gallons in a single-day and a peak 30-day average of 22,944-gpd. Since 2019 the maximum quarterly use was 2,799,485-gallons equating to 933,162-gallons-per-month and an average of 31,105gpd. Therefore, 81,000-gpd is requested in this Consumptive Use Renewal.
