Bowmans Creek Surface Water Withdrawal - Existing Facility Information

The existing water withdrawal and staging area are on property owned by Randy and Laura Wiernusz, the owners of Sugar Hollow Water Services, LLC (Sugar Hollow). The site is located in Eaton Township, Wyoming County, PA. The withdrawal site includes an existing surface water withdrawal from Bowman Creek and staging area with two storage tanks and two filling stanchions. Bowman Creek is designated as an attaining High Quality Cold-Water Fishery with migratory fish (HQ-CWF-MF) under PA Code 25 Chapter 93. The existing withdrawal equipment includes two floating dolphin strainers, withdrawal pump, and flow meter which can be relocated during flood events. Operation began at this site in March 2010.

This surface water withdrawal is currently approved under Docket No. 20180612 for up to 249,000 gallons per day with a maximum instantaneous withdrawal rate of up to 190 gallons per minute. It is used for Bulk Supply for Hydrocarbon Development, Hydrostatic Testing, Horizontal Directional Drilling (HDD), Conventional Bores, Natural Gas Pipeline (Midstream) Operations, Wind Energy Operations, Quarry Operations, and Related Incidental Uses.

This application is a renewal with no modifications proposed. Table 1 below shows the current withdrawal amounts and rates that are being requested for renewal.
