#### **Existing Facility Information**

The existing water withdrawal and staging area are on property owned by Pro-Environmental, LLC (Pro-Environmental). The site is located in Lathrop Township, Susquehanna County, PA. The withdrawal site includes an existing surface water withdrawal from Martins Creek and staging area with four (4) storage tanks and two filling islands that allow four (4) trucks to fill simultaneously. Martins Creek is designated as an attaining Cold-Water Fishery with migratory fish (CWF-MF) under PA Code 25 Chapter 93. The existing withdrawal equipment includes a buried intake, withdrawal pump, and flow meter which can be relocated during flood events.

This surface water withdrawal is currently approved under Docket No. 20180609 for up to 999,000 gallons per day with a maximum instantaneous withdrawal rate of up to 1,150 gallons per minute. It is used for Bulk Supply for Hydrocarbon Development, Hydro Excavation, Hydrostatic Testing, Horizontal Directional Drilling (HDD), Conventional Bores, Natural Gas Pipeline (Midstream) Operations, Wind Energy Operations, Quarry Operations, Dust Suppression, and Related Incidental Uses.

This application is a renewal with modifications proposed. Table 1 below shows the withdrawal amounts and rates that are being requested for renewal.
