#### 2.0 BACKGROUND

#### 2.1 Project Facility Description

#### A. Site/facility name

Well 7

#### B. Anticipated long-term owner and operator

The Town of Erwin Groundwater Wells are owned and operated by the Town of Erwin.

#### C. Type of facility

The well #7 and pump house operates, and pumps water to the northern and/or southern Town of Erwin water district as needed. The facility also provides disinfection in the form of chlorine gas to bring the groundwater to a potable standard.

#### D. Purpose of the Withdrawal

The projected total water usage will be around 2,274,023 GPD on average in 2040, while the current average demand is 2.16 GPD. Therefore, the Town of Erwin must consider the addition of the proposed Well 7.

#### E. Description of Site Activities

The current site of the well includes a pumphouse, which mainly pumps water to the Addison water storage tank. With the addition of Well 7 to the site, the site will then pump a maximum of 1000 GPM from groundwater sources and distribute the water to the municipality as needed.

# F. Requested Quantity of the Water to be Withdrawn

The Town of Erwin, NY requests that up to 94,683,270 gallons per month be withdrawn from all sources within the municipality. Calculations are shown in section 1.5 Reasonable Foreseeable Need.

# G. Date which Operations Shall Begin

The estimated date for construction shall be June 2023, DOH approval permitting.
